ARCHA4408 Critical Theory and Environmental Design: Philosophy and the Predicament of Architecture in the Age of Consumption

This seminar is based on a series of readings which over the years have directly influenced my own critical state of architecture. In this regard, 20th century German philosophy has had a decisive impact on my own understanding of the dilemma which environmental design faces in an age which is overwhelmed by consumerism. After the introductory lecture, one text will be covered in each successive session. Participating students will be expected to read relatively short salient extracts from the texts under consideration. During the introductory session each student will be allocated a particular seminar in which they will be expected to present the material and initiate discussion. For this reason the course will be restricted to around 16 students. This will entail students working in pairs to present seminars 5-12, I will present the first 4 and the final seminar. Students will be expected to write up their presentations as a final requirement with footnotes, etc.

Students wishing to participate must submit a short text (max 500 words) indicating something of their background and the rationale for their wishing to attend the course.

This text would have a lasting impact on my writing beginning with my essay "Labor, Work and Architecture" as this appeared in 1968 in Charles Jencks and George Baird's anthology *Meaning in Architecture*. The second reflection on the work of Hannah Arendt came with my essay "The Status of Man and the Status of his Objects", published in *Architectural Design* 1982.
